RACE DETAILS

9:30 am – 5 mi and 10 mi Trail races, 12:00 PM - 7 mi, 13 mi, and 20 mi Mt. Bike races. Both race courses are located on twisty, turny technical single track and rolling double track trails.

RACE FESTIVAL

A day long family fun festival featuring Groomer Dave’s Oktoberfest food tent, live bluegrass music featuring Matt Meyer and the Gumption Junction, and kid’s activities including trail running and Mt. Bike races. Beer tent provided by the Liberal Cup of Hallowell, Maine. Meal tickets are \$5 for registered racers, and one free beer ticket (for those 21 yrs and over) is included with the registration fee. Food tickets and beer can also be purchased by spectators on race day.

BIKE SUPPORT

Mathieu’s Cycle & Fitness Store will be providing pre-race and course mechanical support for the Mt. Bike races.

AWARDS

Awards for the 5 mi and 10 mi trail races will go to the top 3 overall male and female finishers, to the 1st place male and female in age categories of 19 and under, 20 – 29, 30 – 39, 40 – 49, 50 – 59, 60 and over, and to the 1st place M, F, and mixed Team (Teams - 3 person minimum) . Awards for the Mt. Bike race will go to the top 3 overall male and female finishers in the Novice, Sport, and Expert/Pro classes. Compete in the 5 mi Trail race and 7 mi Mt. Bike race and be eligible to be crowned the Bond Brook Tread Fest King and Queen!!

**PLEASE READ THIS ACKNOWLEDGEMENT, WAIVER AND RELEASE FROM LIABILITY
("AWRL") BEFORE REGISTERING**

I understand and acknowledge that both trail running and mountain biking are extreme tests of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. I HEREBY ASSUME THE RISKS OF PARTICIPATING IN THIS EVENT. I certify that I am physically fit, have sufficiently trained for participation in this event, and have not been advised against participation by a qualified health professional. I understand and acknowledge that my statements on this AWRL are being accepted by Augusta Trails and the City of Augusta, the race sponsors, organizers and administrators in consideration for permitting me to participate in this event. In consideration for allowing me to participate in this event, I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns, or anyone else who might claim or sue on my behalf, and I expressly acknowledge that it is my intent to take these actions: (a) I AGREE to abide by the Competitive Rules adopted by and for this event; (b) I AGREE that prior to participating in this event I will inspect the race course, facilities, equipment, and areas to be used and if I believe any are unsafe I will immediately advise the person supervising the event; (c) I AGREE to cover the replacement costs of any timing chips/ankle straps that I lose; (d) I WAIVE, RELEASE, AND FOREVER DISCHARGE from any and all claims, losses (economic and non-economic), or liabilities, for death, personal injury, partial or permanent disability, property damage, medical or hospital bills, theft, or damages of any kind, which may in the future arise out of, result from, or relate to my participation in or my traveling to or this event, THE FOLLOWING PERSONS OR ENTITIES: AUGUSTA TRAILS, CITY OF AUGUSTA, EVENT SPONSORS, RACE DIRECTORS, EVENT PRODUCERS, VOLUNTEERS, ALL STATES, CITIES, COUNTRIES, OR OTHER GOVERNMENTAL BODIES OR LOCATIONS IN WHICH EVENTS OR SEGMENTS OF EVENTS ARE HELD, AND THE OFFICERS, DIRECTORS, EMPLOYEES, REPRESENTATIVES AND AGENTS OF ANY OF THE FOREGOING, EVEN IF SUCH CLAIMS, LOSSES, OR LIABILITIES ARE CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF THE PERSONS I AM HEREBY RELEASING OR ARE CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF ANY OTHER PERSON OR ENTITY; (d) I ACKNOWLEDGE that there may be traffic or persons on the course route, and I ASSUME THE RISK OF RUNNING AND/OR MOUNTAIN BIKING AND OTHERWISE PARTICIPATING IN THIS EVENT under these circumstances. I also ASSUME ANY AND ALL OTHER RISKS associated with participating in this event including but not limited to falls, contact and/or effects with other participants, effects of weather including heat, cold, and/or humidity, precipitation, lightning, defective equipment, the condition of the trails, water hazards, contact with other participants, running barefoot, running with minimal footwear, mechanical bicycle problems, and any hazard that may be posed by spectators or volunteers, all such risks being known and appreciated by me; and I further acknowledge that these risks include risks that may be the result of the negligence of persons or entities mentioned above in subpart (d) or of other persons or entities. I FURTHER COVENANT AND AGREE NOT TO SUE any of the persons or entities mentioned above in subpart (d) for any of the claims, losses, or liabilities that I have waived, released, or discharged herein; and I INDEMNIFY AND HOLD HARMLESS the persons or entities mentioned above in subpart (d) from any and all expenses incurred, claims made or liabilities assessed against them, including but not limited to attorneys' fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, (i) my actions or inactions, (ii) my breach or failure to abide by any part of this AWRL including but not limited to my covenant not to sue; (iii) my breach or failure to abide by any of the Competitive Rules; or (iv) any other harm caused by me. I FURTHER GRANT FULL PERMISSION to any and all of the above parties to use my name and/or likeness relating to my participation in this event, as well as to use any photographs, videotapes, motion pictures, website images, recordings or any other record of this event, and I WAIVE all rights to any future compensation to which I may otherwise be entitled as a result of the use of my name, image, or likeness.
